1. Nominee must be a member in good standing of SCMGMA with demonstrated leadership abilities to the SCMGMA or their local SCMGMA local chapter. Nominee should have consistently performed above and beyond expectations regarding teamwork, collaboration and partnership.
2. The nominee should be a member of the American College of Medical Practice Executives (ACMPE). The member may be a nominee, certified, or fellow.
3. Candidate should set an example of unique leadership skills in his/her practice and community and have proven experience in the field. The number of years the nominee has been a medical practice executive should be included.
4. A maximum of three (3) letters of support must be attached with this form. At least one letter of support should come from a physician in the member's practice where the nominee is employed, one from his/her SCMGMA local chapter or state board, and one from an additional SCMGMA colleague or member.
